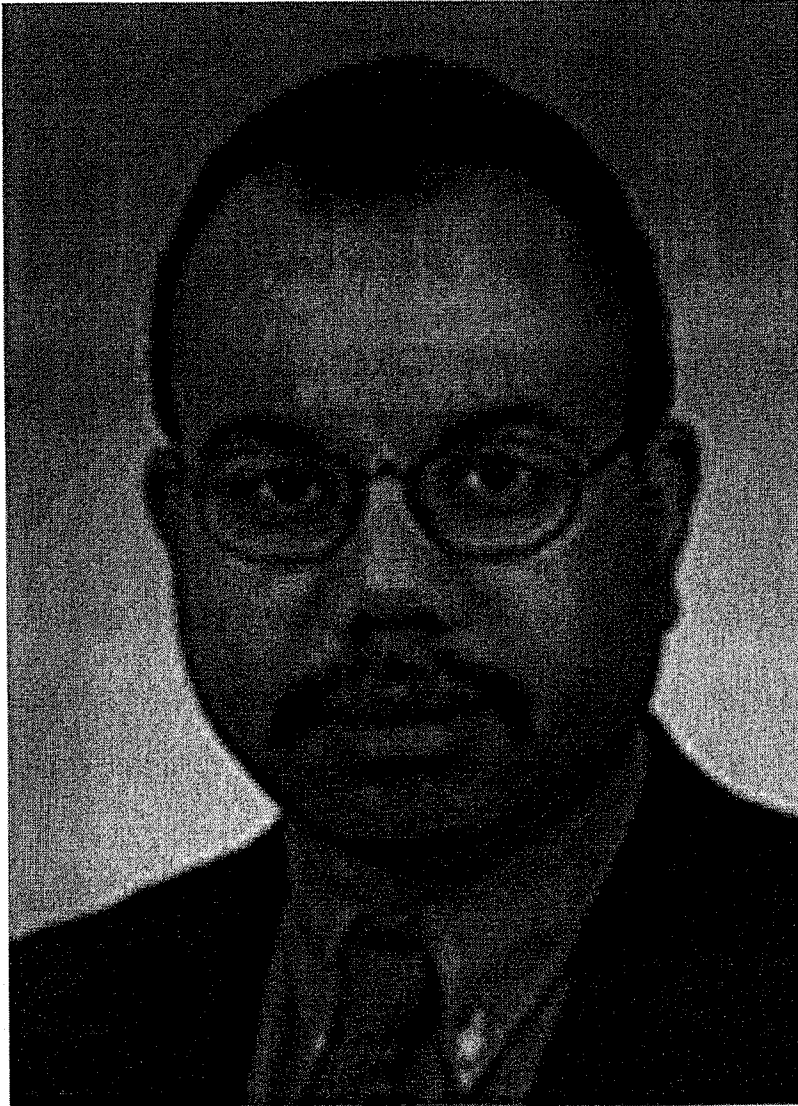

Letter sent to the home of Attorney representing Pacifica

Dear Mr. Reif,

I am a long-time activist in NYC who has listened to WBAI since the early 1960s. I got your address from a flyer handed out at the rally in front of your NYC office last night and decided to write you. I will put it in the mail with the check I have written for \$500 to the Save Pacifica legal fund.

I don't think you people realize what you have gotten yourself into. Now in my mid-50s, I was pretty much retired from politics. But you have re-activated me. Not only will I be giving money to the legal fund to defeat you, I will also be giving my volunteer time to work with Juan González who has correctly characterized you as hijackers. I don't think I have felt as much revulsion toward people in power as I have since the days of Ronald Reagan in Central America or Johnson and Nixon in Vietnam. The naked use of power to advance corporate greed is one thing when it is coming from the Pentagon. It is entirely another when coming from John Murdoch and a bunch of anti-union, greed-consumed crooks operating from the facade of the Pacifica board.
