CAMPAIGN LAUNCHED FOR A FUNDING BOYCOTT OF PACIFICA RADIO'S FIVE-STATION NETWORK

A new organization is calling for listeners of Pacifica radio stations around the country to show their opposition to the current corporate takeover of the network by refusing to donate any money to Pacifica until its current board of directors resigns and is replaced by a new board that is democratically accountable to listeners, staff and the communities the stations serve.

The Pacifica Campaign, the group spearheading the boycott, was hastily founded this weekend following last week's dramatic on-air resignation by Juan Gonzalez, longtime co-host of Pacifica's national flagship news show, Democracy Now!

In his resignation, Gonzalez criticized a "clique" on the board that has "hijacked" the network. That clique, Gonzalez said, has routinely squashed free speech on the Pacifica stations, has violated the civil and labor rights of listeners and staff, and has illegally changed the non-profit network's by-laws in preparation for a possible sale of one or more of the stations.

Gonzalez, who joined with some 35 New York city activists to found the new group this past weekend, is serving as interim coordinator of the campaign.

As part of the campaign, the group will seek to pressure individual board members to resign by utilizing non-violent, direct action and by launching an educational campaign to the public that exposes the roles of the individual board members in the current crisis.

Starting today, the Pacifica Campaign will have five full-time volunteer organizers and scores of part-time volunteers working on the effort. We have

the effort. We have also retained the services of Ray Roger's Corporate Campaign Inc., a group that specializes in mounting nationwide boycotts against anti-labor and anti-community organizations.

In the few days since Juan Gonzalez's resignation, the campaign has been flooded by thousands of e-mails and phone calls of support from Pacifica listeners who want to help.

Organizers will be contacting those listeners directly during the next few days. Meanwhile, we urge all listeners to do the following:

1) DO NOT PLEDGE ANY MONEY TO ANY PACIFICA STATION

2) IF YOU HAVE ALREADY PLEDGED MONEY, DO NOT SEND YOUR CHECK IN

3) CONTRIBUTE MONEY INSTEAD TO THE PACIFICA CAMPAIGN, OR TO THE THREE LEGAL SUITS CURRENTLY CHALLENGING THE BOARD'S LEGITIMACY, OR TO A LOCAL LISTENER GROUP IN YOUR AREA -- IN SHORT, TO THOSE FIGHTING TO REFORM PACIFICA TAX DEDUCTIBLE CONTRIBUTIONS TO THE PACIFICA CAMPAIGN CAN BE MADE PAYABLE TO:

5) DO NOT COOPERATE WITH PACIFICA'S FUND
DRIVE BY
OFFERING AS PREMIUMS ANY BOOKS OR TAPES
YOU HAVE
AUTHORED OR PRODUCED.

Also, do not be confused if you hear the host of your favorite show urging you on-the-air to pledge money. Many producers and hosts are opposed to the policies of the current board of directors, but they are prevented by gag rules from voicing their displeasure and they must ask for pledges from listeners or they can be fired. It is important to keep shows like Democracy Now! on the air.

For now, we are urging producers who oppose the board to keep soliciting pledges but to "work to rule," i.e., do the minimal amount of fundraising work and with as little enthusiasm as possible.

As we reduce the money coming into Pacifica we will reduce the board's ability to continue its anti-listener policies. At the same time, we will be increasing the pressure on individual board members, until they have no recourse but to resign.

We will oust the hijackers and return Pacifica to its original mission.

Dear Listeners and Friends,

As the crisis deepens at WBAI radio (99.5 FM), we are excited to learn that not only has a coalition of listener groups organized itself in New York City, but a growing movement is taking shape in Long Island, Rockland County, Westchester, New Jersey, Connecticut, and at our sister stations around the country. Concerned Friends of WBAI is joining with these efforts to return "listener-sponsored" radio to the original mission of Pacifica as envisioned by founder Lew Hill, as a progressive community radio network independent of corporate or government control.

With WBAI's Winter fund drive now underway, it is time to redouble our efforts to challenge the looming corporatization and possible sale of our station. Concerned Friends of WBAI is helping to organize economic as well as political and legal campaigns against a corrupt Pacifica National Board and the new management it has installed at WBAI. Concerned Friends is an independent organization of listeners, community members and staff dedicated to the democratization of WBAI and Pacifica.

Many of us have come to the painful conclusion that we can no longer contribute funds to WBAI under the circumstances that now prevail at the station. Furthermore, because Pacifica has now taken control of the bank accounts of the station, whatever we contribute goes directly to funding the authoritarian regime at Pacifica and the corporatization of WBAI radio. **Please join with hundreds of other subscribers in refusing to give money to WBAI/Pacifica under current conditions. An independent "Listeners' Fund" has now been established by Concerned Friends of WBAI to accept contributions. (This fund is separate and apart from any accounts under the control of or managed by Pacifica or WBAI.)**

We are asking for your financial contribution in conjunction with another part of our campaign to bring about changes in the current policies of WBAI and Pacifica: the "Listener's Pledge", which we urge you to sign and return to Concerned Friends of WBAI. At the conclusion of the Winter fund drive, these "Pledges" will become a tangible measure of listener dissatisfaction and demand for change at WBAI.

In sum, we are asking you to do the following: 1) Send a tax-deductible contribution to the Concerned Friends "Listeners' Fund"; and, 2) Sign the "Listener's Pledge". We also welcome and encourage your participation in the local and national campaigns described in the following.

- National Corporate Campaign Project to Oust the Pacifica National Board. This project, initiated by Juan Gonzalez (who resigned recently as co-host of Democracy Now!), will work on a nationwide level to oust the undemocratic clique that has hijacked the Pacifica National Board, and to replace them with a board that is democratic and accountable to listeners, community and staff. As part of the overall effort, this Project's sponsors are urging listeners to withdraw all financial support for Pacifica until these goals have been met, and to join the Campaign in actively exposing the corporate and economic interests of the union-busting clique now running the National Board.
- Democratic Election and Empowerment of the Local Advisory Board. While there are very good people on the Local Advisory Boards connected to each of Pacifica's five stations, the National Board has made decisions undermining the authority of the LABs and has proposed new bylaws that would further erode the local boards. To establish greater legitimacy, and to bring thousands of new listeners directly into the process, KPFA in Berkeley recently conducted an election among subscribers to the station to choose their Local Advisory Board. We are working toward a similar process here in New York in which we hope to create a representative, democratic advisory board and strengthen the lawsuits and other efforts to democratize Pacifica.
