That we, the undersigned residents of the State of California, have voluntarily essociated ourselves together for the purpose of forming a non-profit corporation under and by virtue of the laws of the State of California, and particularly under the provisions of Article I of Title XII, Part IV, Division 1, of the Civil Code of the State of California, and

WE DO HEREBY CERTIFY:

That the purposes of this corporation shall be:

- (d) To establish and meintain radio, school, newspaper, printing publishing, and bookstore facilities, and any other activities that may be deemed necessary or appropriate to the carrying out of any of the purposes of this corporation.
- (e) To do such things end engage in any such activity as shall serve the educational, recreational and cultural welfare of its members and the public.

That the authorized number and conditionations of its memoers, the different classes of membership, if any, and the property, voting and other rights and privileges of each class of membership shall be set forth in the By-laws of the corporation, and no member of this corporation shall ever be liable to said corporation for any dues or assessment beyond the membership fee provided for at the time of his admission to membership in sail corporation.
